From_the_President

Greetings! It is my distinct honor to be your President for the 1998-99 year, and I look forward to working with the Executive Council during my tenure in office.

The Association of Third World Studies (ATWS) held its Sixteenth Annual Meeting in Durham, North Carolina, October 8-10, 1998. The commitment and support of the participants helped to make the Conference a success! Furthermore, the Local Arrangements Committee members deserve special thanks for their dedication! In addition, let me take this opportunity to thank Donald Simmons who urged me to run for office in the first place.

The ATWS annual meetings allow members to express their debt of gratitude, by carrying his torch, to the Association's founder, Harold Isaacs. Since its inception in 1983, the ATWS has grown both in membership and professional activities, including publication of the JOURNAL OF THIRD WORLD STUDIES, A.T.W.S. CONFERENCE PROCEEDINGS, and A.T.W.S. NEWSLETTER. Furthermore, the Association is proud of its chapters in Africa and South Asia. Thanks to Marcia Jones, the Fifteenth Annual Meeting in Connecticut marked a quantum leap in publication of the Conference Program. The Sixteenth Annual Meeting in North Carolina successfully implemented the pre-registration policy (for Conference participants) and introduced Conference paper sale. Tom Leonard will take the forthcoming Seventeenth Annual Meeting to Costa Rica, the first time that ATWS will hold its Annual Meeting in the Third World. Hopefully, the Conference will promote an ATWS chapter in Latin America!

As ATWS grows, understandably, it will experience "growing pains," particularly during its teenage years. Consequently, there is a greater need to institutionalize the processes for organizational management. During my tenure in office, I plan to work with the Executive Council in four areas: professional excellence, transparency, outreach, and diversity.

The conference paper sale was an additional step in giving a professional image to our Annual Meetings. It not only implies that discussants have completed papers, but also that colleagues can benefit from a copy.

While the Association is delighted to have regional chapters, it would be helpful to have greater opportunity for interactions between the regional and international bodies. In addition to periodically holding the international meeting in the Third World, it would be enriching to have scholars from the chapters participate at the Annual Meetings. Funding, of course, is a challenge in that outreach effort. As ATWS has grown, so has the diversity of its membership. That diversity could be better reflected in the decision-making process of the Association. Such an outcome warrants greater willingness

The-ATWS-Book-Length-Award Renamed for Cecil B. Currey

The ATWS Book-Length Publications Award was recently renamed for Dr. Cecil B. Currey in honor of his generosity in supporting the award. Dr. Currey, a well-kown authority on the history of Vietnam, became the first recipient of the ATWS Book-Length Publications Award. Created by Dr. Bill Head in 1997, the award recognizes the success of an ATWS member in producing a book-length publication.

Professor Emeritus of History at the University of South Florida in Tampa, Dr. Currey still teaches part-time and has a total of 32 years of service at USF. A prolific scholar who has written a total of 15 books and many chapters in books, articles, review essays, and reviews, Dr. Currey is well-known for publications such as *Victory at Any Cost*, a biography of Vo Nguyen Giap, the great Vietnam general.

Dr. Currey is a full retired Colonel in the National Guard and U.S. Army Reserve and has served as a chaplain for 27 years.

Third-Annual-South-Asia-Chapter-ATWS Conference Held in Trivandrum, Kerala, India

The third annual conference of the ATWS-South Asia chapter was held at Trivandrum on March 7-8, 1998.

On March 7 at 9:30 A.M., there was an inaugural session which was chaired by Dr.Isaiah Azariah, president of the ATWS-South Asia Chapter. Dr. Anand Inbanathan, secretary of the ATWS, welcomed the gathering. Dr. K.K. Kusuman, chairman of the program committee, made the introductory remarks and this was followed by the inaugural address of Mr. R. Ravindra Kumar, additional director, Electronics Research and Development Centre unit of ER & DEI, a scientific society of the Department of Electronics, Government of India. He stressed environmental pollution, which invited, among other things, genetical problems. It was followed by the presidential address of Dr. Azariah who explained in brief the activities of the ATWS-South Asia Chapter in the past two years. Mr. Raja Thankam, secretary, conference arrangement committee, proposed a vote of thanks.

The inaugural session was followed by panel sessions. The general theme of the conference was "India on the Brink of Twenty-first Century". The first session was chaired by Dr. V. Yesudhason. Dr. Padmaja A. Patil (Shivaji University, Maharashtra), Dr. K. Jyothikamalam (Department of Demography, University of Kerala), Dr. R. Sooryamoorthy and Dr. D. Renjini (Loyola College, Trivandrum), presented papers on various aspects of women's problems.

The second session, which focused on women's problems, was chaired by Dr. V. Balambal. Dr. L.K. Sivanesan (reader in history, Periyar E.V.R. College, Trichy, Tamilnadu), Dr. V. Sathianesan (reader of the same college), and Dr. K.G. Vijayalakshmi (assistant population education officer, Family Planning Program of India) presented papers.

The third session was presided over by Dr. M. Kuttappan, director of economics and statistics, Govt. of Kerala. Dr. M. Kunhaman (reader in economics, University of Kerala) and Mr. C. John Rose presented papers. These two papers analyzed certain aspects of the economic problems faced by third world countries, with particular reference to India.

The fourth session was chaired by Dr. K. Sadasivan, professor of history, M.S. University, Tamilnadu. Dr. E. Marimuthu, Mrs. P. Vasumathi Devi and Dr. S.M. Mohammad Koya presented papers. The authors discussed some of the socio-economic problems of South India.

The fifth session concentrated on environment. The session was chaired by Dr. K. Narayanan Nair (formerly scientist, V.S.S.C., Thumba). Papers were presented by Dr. A. Prasanna (Govt. Law College, Trivandrum), Dr. K.G. Vasanthamadhava (fellow, I.C.H.R., University of Calicut), and Dr. P. Hymavathy (reader in history, Kakatiya University, Andhra Pradesh).

The sixth session was chaired by Dr. L.K. Sivanesan and papers on women's problems were presented by Dr. K. Sadasivan and Dr. V. Balambal.

On March 8, 1998, the valedictory session at 4 P.M. was chaired by Dr. Azariah. The gathering was welcomed by Smt. P. Vasumathi Devi. The valedictory address was given by Dr. P. Jayasingh, principal, N.M. Christian College, Tamilnadu. Dr. P. Rajalingam proposed a vote of thanks.

M. Bazlul Karim was the recipient of the *Presidential Award* presented by Dr. Marcia Jones for his outstanding contribution — the ATWS website.

John M. Mbaku won the "Cecil B. Currey ATWS Book-Length Publications Award" given for the best book published by an ATWS member during the previous year. John received his award for the book he published in 1997 entitled *Institutions and Reform in Africa: The Public Choice Perspective* (Praeger).

Dr. Osita G. Afoaku, associate professor, Department of Africana Studies, University of North Colorado, received the *Reddick Award for Best Article on Africa*. His article entitled, "The U.S. and Mobutu Sese Seko: Waiting on Disaster" was published in the Spring 1997 issue of the *Journal of Third World Studies*, Vol. XIV, No.1, pp.65–90.

ATWS's 16th Annual Meeting was held from October 8–10, in Durham, North Carolina, at the Regal University Hotel.
